## MEMBERSHIP CLASSIFICATION RATES, & PAYMENT OPTIONS 2026

---

### Regular Individual Membership - \$950.00

Persons thirty-five (35) years old or older who pay an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year.

---

### Regular Family Membership - \$1250.00

Married couples and/or their dependent children that have paid an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year.

---

### \*\* First Time Members Receive Half-Off "Regular Individual Membership" - \$475.00

Persons eighteen (18) years old who pay an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year. To receive this you must be a first time ever member.

There will also be a \$100 administration fee to get you into our system.

---

### \*\*First Time Member Receive Half-Off "Regular Family Membership" - \$625.00

Married couples and/or their dependent children that have paid an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year. To receive this you must be a first time ever member.

There will also be a \$100 administration fee to get you into our system.

---

### Individual Under 35 Memberships - \$750.00

Persons under the age of thirty-five (35) years old who pay an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year.

---

### Family Under 35 Memberships - \$1050.00

Married couples and/or their dependent children that have paid an annual membership fee will have privileges and use of the golf course and clubhouse facilities for a calendar year. To receive this Membership the oldest adult must be under the age of thirty-five(35)

---

### Student Member (High School) - \$350.00

Youth, seventeen (17) years of age or younger who are not dependents of a current member may purchase an annual High School Student Membership for a calendar year.

---

### Student Member (College) - \$500.00

Individuals, twenty-four (24) years of age or younger and who are enrolled full time in a Trade School, College, or University may purchase an annual College Student Membership. Full time enrollment is at least twelve (12) hours or more per semester. Proof of enrollment is a requirement at the beginning of each golfing season.

---

### Annual Golf Cart Rental – (1) PCC Cart = \$500.00

As an *Annual Golf Cart Renter*, you will have unlimited use of *One (1)* golf cart, two riders, per day, all day.

If you need a second cart, the golf shop will rent an addition golf cart on a first-come, first-serve basis.

Must be 16yrs old with valid driver license to operate any PCC Cart on the course.

### Private / Personal Sheds:

**On Premise – Usage Fees for Personal Golf Carts Stored on Club Property - \$200.00 (Trail Fee)**

**Off Premise – Usage Fees for Personal Golf Carts - \$150.00 (Trail Fee)**

**Personal Shed or G/H Shed Fee (Metal or Wooden) - \$500.00** (see Clubhouse Manager for current locations available for sale)

### Membership Payment Options:

A Payment Plan can be made for any other form of memberships typically in a 4-5month block. Talk with the Clubhouse Manager on these options. (All Payments will be charged on the 15<sup>th</sup> of the Month.)
